



INSTRUMENT OF GOVERNMENT

BOURNEBROOK CHURCH OF ENGLAND PRIMARY SCHOOL

- 1. The name of the school is **Bournebrook Church of England Primary School.**
- 2. The school is a Voluntary Controlled school.
- 3. The name of the governing body is **The Governing Board of Bournebrook Church of England Primary School**.
- 4. The governing board shall consist of:
 - 2 Parent governors
 - 1 Local Authority governor
 - 1 Staff governor
 - 1 Headteacher
 - 3 Foundation governors (including ex-officio governor)
 - 6 Co-opted governors
- 5. The total number of governors will be **14** (except at any time when the Headteacher has given notice that they choose not to be a governor, when the total number of governors will be **13**).
- 6. The term of office for all governors is **four** years.
- 7. Foundation governors shall be appointed by the Coventry Diocesan Board of Education in consultation with the Parochial Church Councils of St. Mary and All Saints Church, Fillongley and Corley Parish Church, Corley.
- 8. a) The holder of the following office shall be a foundation governor ex-officio: *the Incumbent of the ecclesiastical parishes of Fillongley and Corley.*
 - b) The Diocesan Director of Education and the appropriate Archdeacon shall appoint a foundation governor to act in place of the ex-officio foundation governor whose governorship derives from the office named in a) above, in

the event that the ex-officio governor is unable or unwilling to act as a foundation governor or has been removed from office under regulation 21(1) of the Regulations.

- 9. The Diocesan Director of Education and the appropriate Archdeacon are entitled to request the removal of any ex-officio foundation governor and to appoint any substitute governor.
- 10. Statement of Religious Ethos:

Recognising its historic foundation, the school will preserve and develop its religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.

The school aims to serve its community by providing an education of the highest quality within the context of Christian belief and practice. It encourages an understanding of the meaning and significance of faith and promotes Christian values through the experience it offers to all its pupils.

- 11. This Instrument of Government comes into effect on 29th January 2024.
- 12. This Instrument was made by order of Warwickshire Local Education Authority on **26**th **January 2024.**
- 13. This variation takes effect on **29**th **January 2024**.
- 14. A copy of this Instrument must be supplied free of charge to every Member and Associate Member of the Governing Board (and the Headteacher if not a Governor), the Trustees of the foundation of the school and the Diocesan Director of Education for Coventry Diocesan Board of Education.
